

# Hungry Duck Run

## 3rd Annual Half Marathon & 5K

### July 4th, 2009 Brighton, Michigan



**Location:** Start and finish in downtown Brighton on St. Paul just east of Grand River.

**Time:** Half Marathon at 7:00 AM; 5K Run/Walk at 7:15 AM; Duckling Dash (10 & under) at 9:30 AM. On Main Street by the Mill Pond.

**Course:** Varied course starting in downtown Brighton, continuing into local scenic areas and returning downtown for finish. Course is mostly paved with portions on hard-pack dirt roads; mostly flat with a few modest hills to add a little challenge; mostly shaded. Half marathon course will be closed at 9:45 AM.

**Entry Fee:** Half Marathon: Early - \$40; Late - \$50  
5K: Early - \$25; Late - \$30  
(Early Feb 1 through June 28; Late - after June 28)

**Pre-Registration:** Online through June 28; mail-in (must be postmarked by June 28); in-person during packet pickup.

**Race Day Registration:** Start/finish area (St. Paul just east of Grand River) - MUST BE IN LINE BEFORE 6:30 AM.

**Packet Pickup:** (PRE-RACE) July 2 from 3 PM - 7 PM; July 3 from Noon - 7 PM at Runnin' Gear - 9937 E. Grand River Ave., Brighton, MI (810) 844-0180; (RACE DAY) July 4 from 5:30 AM - 6:30 AM at start/finish area (St. Paul just east of Grand River) MUST BE IN LINE BEFORE 6:30 AM.

**Awards (Chip Time):** Top men & women overall and Masters; Three Deep (M&W) in all 5 year age categories! (NOTE: A \$30 fee will be charged for timing chips not returned.)

**Included with Registration:** Timing chip, commemorative **Tech Shirt**, huge post race-food spread, goodie bag and entry in Rotary's Duck Race Raffle (\$5 value). Shirts not guaranteed for late entries; late entries will not receive Duck Race Raffle Ticket.

**Parking:** Available/recommended at Brighton High School to avoid parade route and traffic. Free shuttle service provided by race staff!

**Happenings:** Brighton Independence Day parade starts at 10:00 AM immediately followed by the Livingston Sunrise Rotary Club's Duck Race raffle (more info on our website).

**Why will this year's race be awesome?** Tech shirts; Chip timing; sports drink on the course; more food at the finish (rumored to include something deep fried!); Duckling Dash (10& under kids run); qualifying race for Governor's Council on Physical Fitness Mackinac Bridge Run; the return of Waddlesworth the Duck and the Gleaner's Can Man mascot!

**Acknowledgement of Dangerous Activity.** By signing below, I acknowledge that my participation in the 2009 Hungry Duck Run and/or any pre- or post-Event activities (collectively, the "Event") involves rigorous physical activity and that it potentially may be hazardous. I attest and verify that I am physically fit and have sufficiently trained for the Event and that, if appropriate, my physical fitness to participate in the Event has been verified by a licensed medical doctor. I expressly assume all risks associated with the Event, including but not limited to: loss of or damage to my property; injury (including death); terrain conditions that may vary widely, spectators, participants, and natural and man made obstacles (including without limitation, vehicles, security barriers, signs, cables, mats, and debris on the course).  
**Waiver and Release.** In consideration of my participation in the Event, I, for myself, my heirs, executors, administrators, personal representatives, successors and assigns, waive any and all rights, claims and causes of action I have or may have against any Race Organizer that may arise as a result of participation in the Event with respect to any bodily injury, personal injury (including death), illness, or property damage. For these purposes, a "Race Organizer" is any one or more of the following: The Hungry Duck Run, The City of Brighton, Brighton Township, The Livingston Sunrise Rotary Club, Rotary International, Gleaner's Community Food Bank, all sponsors, volunteers, and staff, medical service providers and all governmental agencies representing the territory in which the Event will be held together with their subsidiaries, successors, heirs, contractors, subcontractors, directors, officers, agents, attorneys, and representatives of each of the foregoing. **Indemnity.** I hereby agree to indemnify all Race Organizers for all claims and losses (including attorney's fees and court costs), which may be brought against any one or more of them by claiming to have been injured or otherwise to have suffered loss or damage as a result of my participation in the Event. **Publicity and use of my Likeness.** I further grant full permission to any and all of the foregoing to store, use and/or reproduce any image or likeness of me by any audio and/or visual recording technique (including electronic/digital) now in existence or hereafter invented, for any legitimate purpose, including commercial sales and marketing purposes. I understand and agree that information about me that is collected by the Race Organizers, including without limitation information on this form, and my Event results, may be disclosed to third parties for any legitimate purpose, including commercial sales and marketing purposes, and that it may be subject to re-disclosure by the recipient(s). I also grant permission to any of the foregoing to store and disclose as reasonably necessary for my health treatment any and all health information that I may disclose to Event medical personnel. **Rules.** I acknowledge and agree to abide by any Official Rules for the Event that may be posted at the Event or on the Event's website. My failure to abide by these rules may result in disqualification or ejection from the event. I hereby represent and warrant that I am 18 years of age or older or, if applicable, that I am the parent or legal guardian of the child under the age of 18 years old who I am registering for the Event and that I have the full power and authority to agree to these terms on behalf of such child, and to bind myself and him/her to these terms. I understand that this event will be chip timed and I will be charged \$30 if I fail to turn in my chip at the end of the race. **Other.** I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Michigan and that this Release shall be governed by and interpreted by the laws of the State of Michigan. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforced.
